ANNUAL MEETING OF SARON UCC

SUNDAY, JANUARY 21, 2024

The meeting was called to order by President Doug VanHelden at 10:40 am.

Doug VanHelden led us in prayer.

There were eighty-one people in attendance as recorded on the signup sheets.

Carl Laack made a motion to have Doug as moderator and Judy Glander as secretary. Lee Post seconded the motion. All in favor and motion carried.

Nominees for Consistory, Board of Christian Ed, Trustee, Cemetery Board and Endowment were put up on the screen in front of church. President Doug VanHelden asked for any other nominations from the floor three times.

Jay Flegal made a motion to close the nominations and Ron Roehl seconded it. The ballot counters were Katie VanHelden, Brian Rautmann, Janine Gardapee and Luke Kwekkeboom.

President Doug VanHelden had the members look over the minutes from the 2023 annual meeting. Roy Herzog made a motion to accept the minutes as printed and Lee Post seconded it.

Barb Post read the Pastor's Report that Pastor RaeAnn had written. Doug thanked Barb for reading this.

Doug gave his President's Report. He thanked the Consistory members for their dedication and for the opportunity to serve the last 3 years. He reviewed some of the projects that we have completed or are still ongoing. Some of these projects include landscaping for the septic system, water issue in the church basement with new larger gutters, downspouts and splash shields being installed on the north side of the narthex. He mentioned that the physical care of Saron is ongoing and will continually be addressed as needed. Doug's focus this past year as President was to question "what is Saron church" who we are and where are we going as a church also, to move beyond the physical needs of the church but the spiritual needs. Doug also mentioned we have seen an increase in mission opportunities such as potluck lunches with the outdoor



services, coffee/conversation time before church, ushering teams to full groups and involving them more in the service. Midsummer Pastor RaeAnn announced her retirement to the Consistory which now leaves our church in a time of transition. We, as the Consistory have worked diligently to find an interim Pastor, create a Search Committee also, pulpit supply. The Consistory will be collaborating with interim Pastor Gary Wilner, our church conference, search committee and the Church. During this time hopefully we will learn "Who we are as a church and who do we want to become."

Treasurer, Linda Barthels reviewed the 2023 Treasurer's report and the 2024 budget. Danielle Zimmerman questioned the Pastor's Salary, and we were basing the salary this year for the interim on UCC guidelines also for a church our size. This also is guided by the number of years of service. Doug asked for a motion to accept the Treasurer's report. Danielle Zimmerman made a motion to accept the 2024 Budget and Kevin Fleck seconded the motion. All in favor and motion carried.

OTHER BUSINESS:

Parking Lot Maintenance-The Consistory has come up with the following proposal for the parking lot.

Utilize up to \$25,000 from the Improvement Fund to sealcoat, stripe and maintenance of Saron's parking lot and driveway (Excluding cemetery property)

At the budget meeting Allen Nohl made a comment to make sure that when this is being worked on that we distinguish the driving lanes for in and out. We, as Consistory, have gotten some quotes in the last couple of years so these will be reviewed. Carl Laack made a motion to proceed with the project and Lee Post seconded it. We had a ballot vote and it passed. Motion carried.

Cemetery Sign- Jay Flegal gave a detailed description of the new signage that the Cemetery Board would like to have placed on the west cemetery. This sign will be identical to the sign that is on the east cemetery. The following proposal was as follows:

Utilize up to \$22,500.00 from the Memorial Fund to purchase and install a sign on the west cemetery.

Jeff Meinnert questioned if the sign will be set back far enough so it will not be in the right of way of the road. Jay answered yes to the question. Judy Dumke made a motion to accept the proposal and Michelle Johanning seconded it. This was a ballot vote and it passed. Motion carried.

Endowment Fund-Teri Strub gave an update on the distribution of the funds (income and earnings) not principal for the Endowment. Last year it was requested to lower the funds from \$100,000.00 to \$75,000.00. The funds are to be utilized for Christian Education, Community Services and Wider Mission and Saron UCC programs.



Items not eligible for funds are improvements and purchases that relate to buildings and grounds or any other operating expenses of the church (salaries, heating, and cooling, etc.)

In 2024 the available funds for distribution are \$4000.00. The Endowment Committee has an application form to be filled out before the distribution of funds. Teri asked if there were any other questions and there were none.

Doug asked if there was any other business while waiting for the nomination ballots. Larry Boedecker questioned if there still was a committee that would oversee ringing the bell, answering any questions about funerals and or weddings. Doug mentioned that this was discussed at the Consistory's last meeting and before we put up a sign-up sheet, we would like to have a procedure in place. Carl Laack mentioned after the meeting that he would be available to give us some insight and information on this.

Doug asked for a motion to destroy the ballots. Skeeter DeGroff made a motion to destroy the ballots and Danielle Zimmerman seconded it. All in favor and motion carried.

Stan Strub commended the Consistory for the work they did this last year.

Doug asked for a motion to adjourn the meeting. Kathy Depping made a motion to adjourn, and Lee Post seconded it. All in favor and motion carried. The meeting adjourned at 11:25 am.

We closed with the Lords Prayer.
